Biographical Information

Walter H. Simon was born in Quincy, Illinois. He graduated from the University of Illinois School of Architecture in 1915 and first practiced in Eldorado, Kansas. He married Clara Johanna Loos in 1916 and the couple moved to Denver by the early 1920s. Simon worked as a draftsman in 1922 at the architectural firm of William E. Fisher and Arthur A. Fisher. By 1925, he established his own firm. Simon maintained a sole proprietorship for the majority of his practice. In the 1960s he entered into a brief partnership with John B. Hipp.

One of Simon's first major projects was the 1925 design of the Pencol Apartments. Several other apartment commissions followed, including the Aromor Apartment Hotel, the 1928 Casa Grande Apartments, and the 1931 Leetonia Building. Simon is credited with establishing, designing, and constructing the Geneva Glen Camp, a children's summer camp west of Denver. Among Simon's other notable designs are the Stanley Arms (National Register); the Art Deco style Fort Morgan Municipal Fire and Police Building; the Rio Grande County Courthouse; Del Norte Grade School; and the Mission Revival style Ertel Funeral Home in Cortez (National Register).

Simon served on the Colorado State Architect Board of Examiners and was national president of the Society of American Registered Architects. He was active in the Denver Lions Club, the Masons and the Shriners. The Simons were members of Park Hill United Methodist Church, for whom he designed a major addition in 1956.

Simon retired in 1976. He died of pneumonia on December 30, 1986, at the age of 94. He and his wife were interred at Denver's Fairmount Cemetery.
